
Topics for Discussion




- Audit of the SDGs as a special area of government audit: main challenges, approaches and innovations




- Enhancing the competence of SAI staff in the area of the SDGs audit

- What are the weakest points of the global and national SDGs monitoring systems? How to improve the methodology of the development and monitoring of the indicators?


