PFAC COVID-19 INITATIVE

The leadership of INTOSAI's Policy, Finance, and Administration Committee (PFAC) established the INTOSAI COVID-19 Initiative in April 2020 as a short-term initiative to help SAIs around the world continue to serve their citizens and governments while sharing best practices and lessons learned.

COVID-19 INITIATIVE

focused on maintaining continuity of operations within INTOSAI, assisting individual SAIs with their continuity of operations, sharing practical, technical, and audit-related information across INTOSAI members, and developing a high-level lessons learned document on minimizing similar situations in the future.

INTOSAI-COVID-19WEBSITE

In May, the initiative launched a dedicated https://intosaicovid19.org/, website, with helpful information and resources to the INTOSAI community on maintaining continuity of operations, relevant audit reports and methods, and remote work and training tools. The website has 3,800 users visit with over 17,700 page views.
